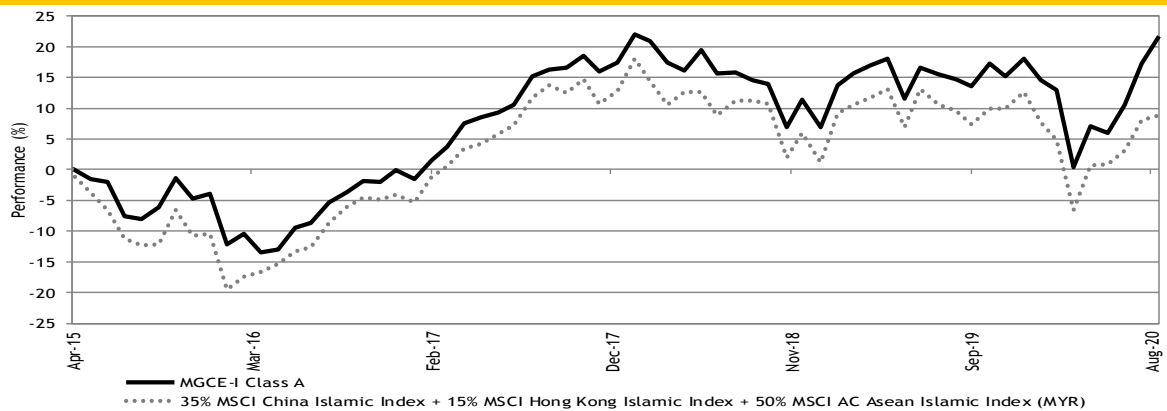

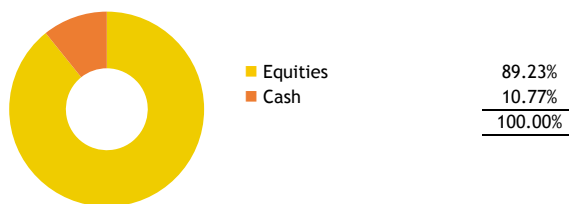

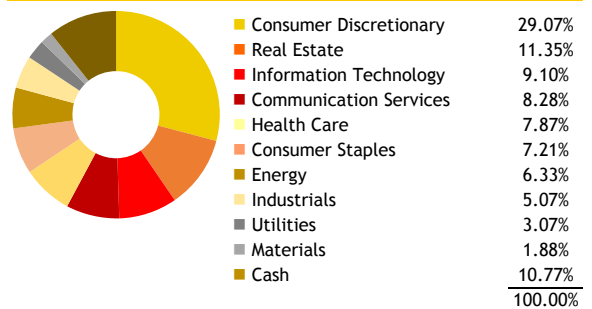

Asset Allocation as at 31-Aug-20



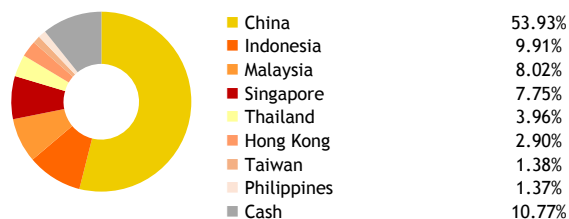

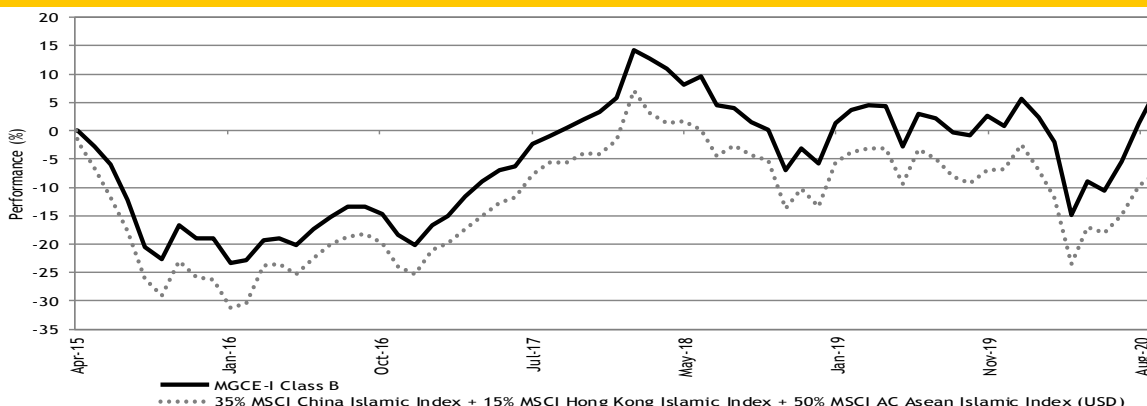

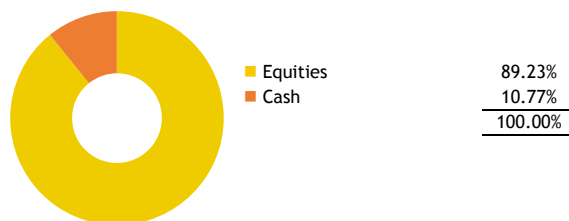

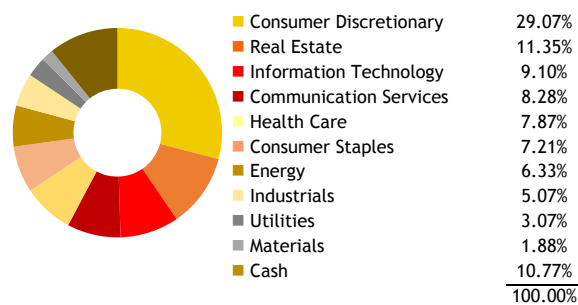

Asset Allocation as at 31-Aug-20



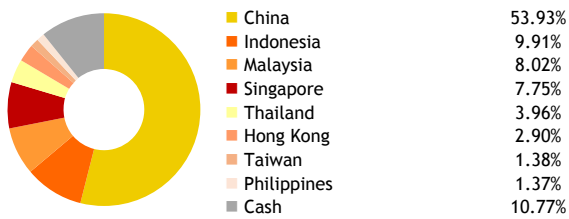

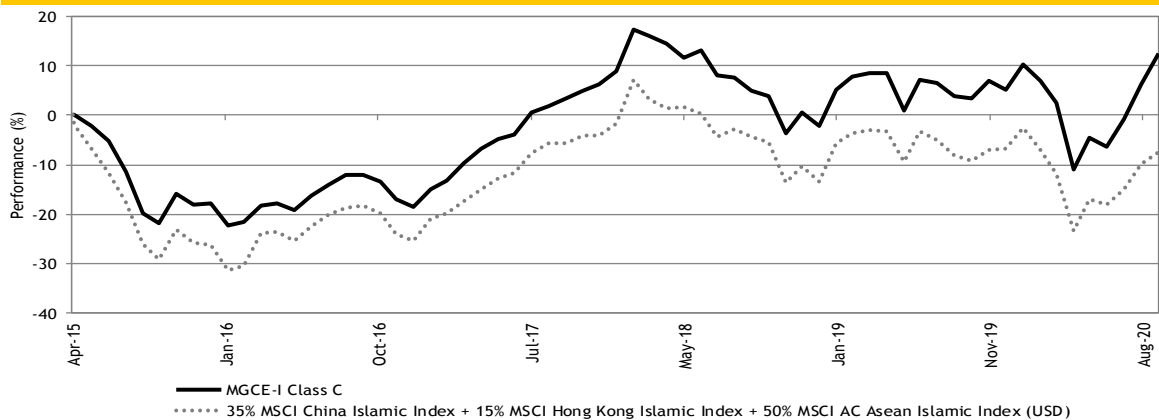

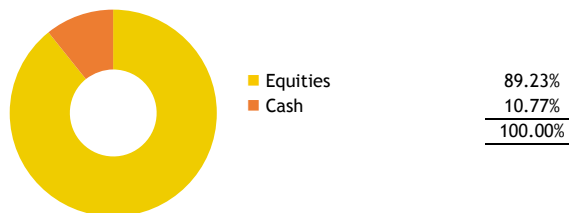

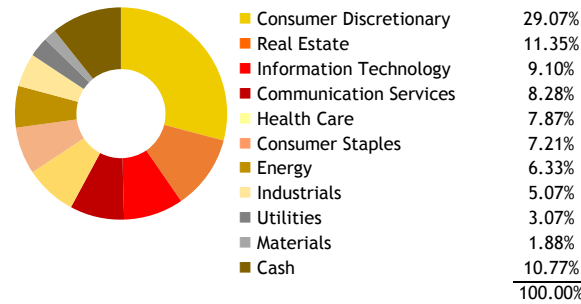

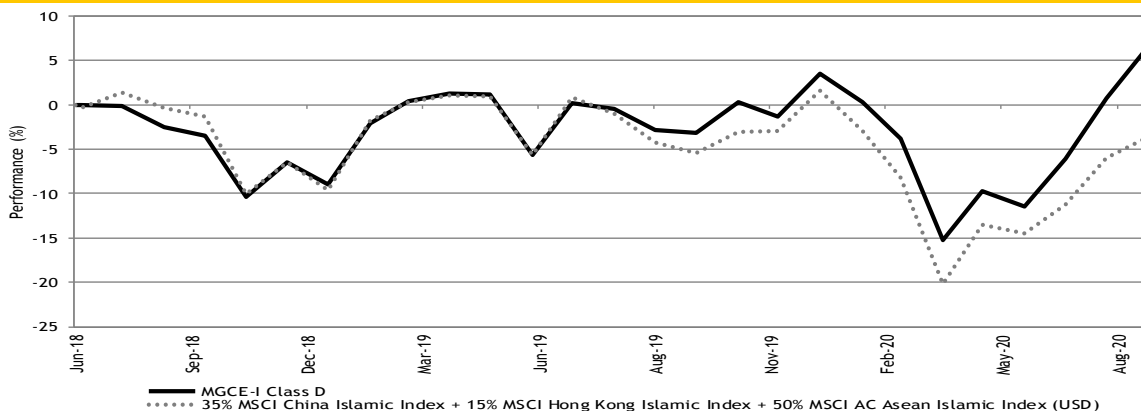

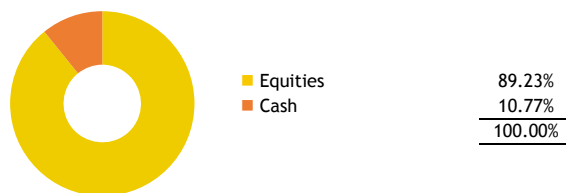

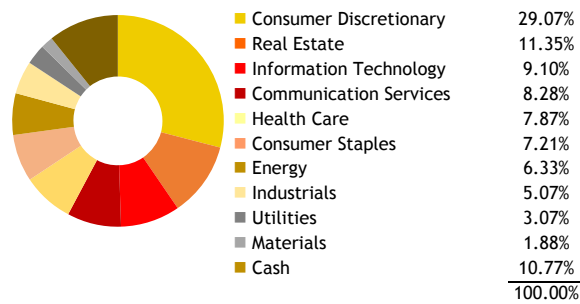

Asset Allocation as at 31-Aug-20



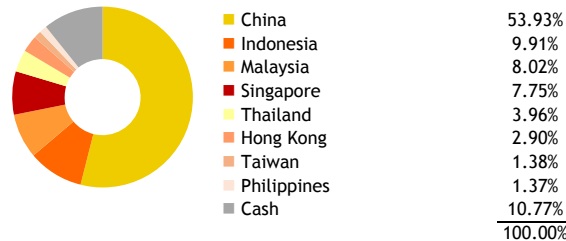
