

#### **FUND OBJECTIVE**

The Maybank Malaysia Dividend Fund ("MMDF" or "the Fund") is an equity fund that aims to provide investors with a regular income<sup>1</sup> stream and to attain Medium

to Long Term capital appreciation through investing in high (and potentially high) dividend yielding equities (including foreign equities). Any material change to the investment objective of the Fund would require Unit Holders' approval.





## Asset Allocation as at 31-Oct-21




