

FUND OBJECTIVE

The Maybank Malaysia SmallCap Fund ("MMSCF" or "the Fund") is an equity fund that aims to achieve Medium to Long Term capital growth by primarily investing into securities of small and medium sized companies:

- (i) listed on the Bursa Malaysia's Main Market, ACE Market and/or any other boards approved by the SC;
- (ii) with market capitalisation of not more than the limit considered by the SC to be appropriate for fund similar to this Fund; and
- (iii) which have the potential for capital appreciation over the Medium to Long Term.

Any material change to the investment objective of the Fund would require Unit Holders' approval.

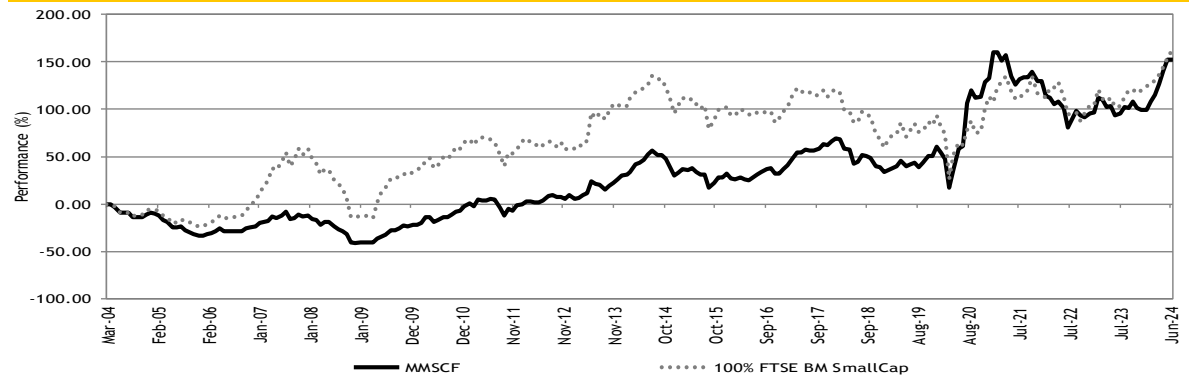

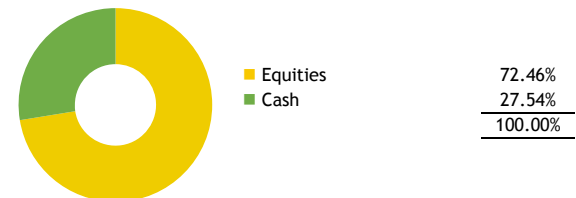

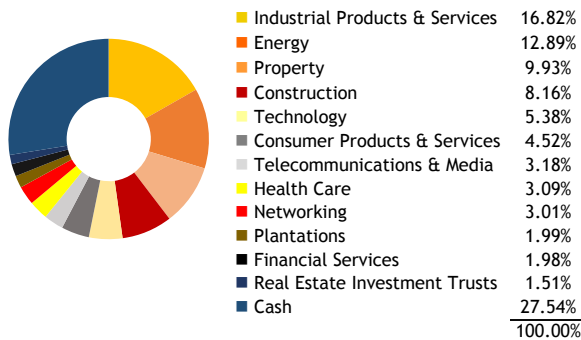

Based on the fund's portfolio returns as at 30 June 2024, the Volatility Factor (VF) for this fund is 13.24 and is classified as "High". (Source: Lipper). The VF means there is a possibility for the fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The fund's portfolio may have changed since this date and there is no guarantee that the fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
