


INVESTMENT OBJECTIVE AND STRATEGY

Rowe Price Funds SICAV - China Evolution Equity Fund (Target fund). The Target Fund aims to increase the value of its shares, over the long term, through growth in the value of its investments. The Target Fund is actively managed and invests mainly in a diversified portfolio of shares of Chinese companies and may have significant exposure to smaller capitalisation companies.




