



The Fund seeks to achieve its investment objective by investing at least 90% of its NAV in 16 USD share class in the BlackRock Global Funds Dynamic High Income Fund (Target Fund). The Target Fund will use a variety of investment strategies and may invest globally in the full spectrum of permitted investments including equities, equity-related securities, fixed income transferable securities, units of undertakings for collective investment, cash, deposits and money market instruments. Currency exposure is flexibly managed.




