

INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to maximise investment returns by investing in the Target Fund. The Fund seeks to achieve its investment objective by investing a minimum of 90% of its NAV in the Maybank Asian Income Fund Class A (Dist) - SGD (the Target Fund). The Target Fund is a Singapore-authorised open-ended unit trust constituted in Singapore and is a sub-fund of Maybank Focus Funds. The Fund will use derivatives such as currency forwards for hedging purposes to manage the currency risk of the Fund's investments and the classes not denominated in MYR.


