

The Fund seeks to achieve its investment objective by investing a minimum of 90% of its NAV into the SEI Liquid Alternative USD Institutional Distributing Class (Target Fund). The Target Fund's investment objective is to provide long-term capital appreciation by implementing a strategy that seeks to approximate the returns of a model portfolio of funds that employ alternative investment strategies (the Composite) constructed by the Investment Adviser.
