



INVESTMENT OBJECTIVE AND STRATEGY



The Target Fund is a Singapore-authorised open-ended unit trust constituted in Singapore. The Fund will use Islamic derivatives such as Islamic currency forwards for hedging purposes to manage the currency risk of the Funds investments and the classes not denominated in MYR.




