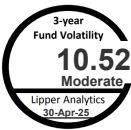

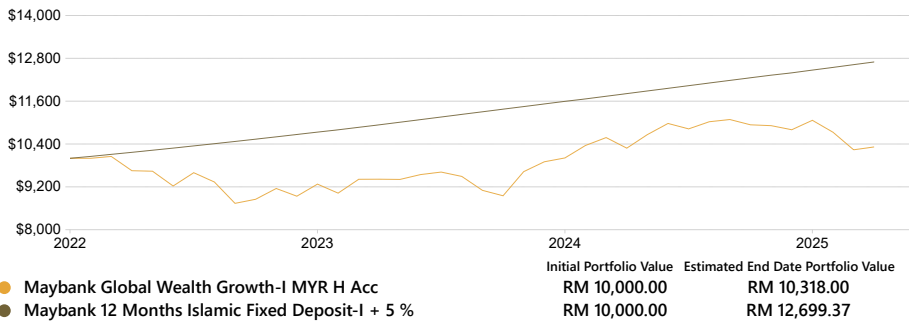

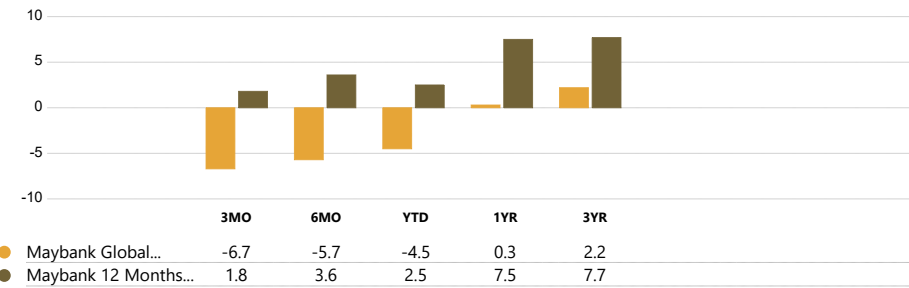
INVESTMENT OBJECTIVE AND STRATEGY

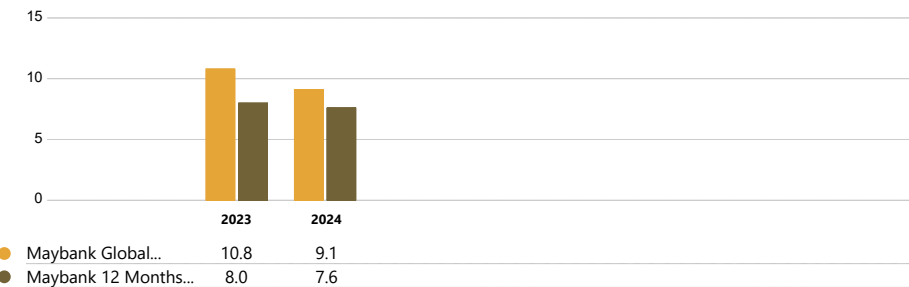
GROWTH OF \$10,000 INVESTMENT



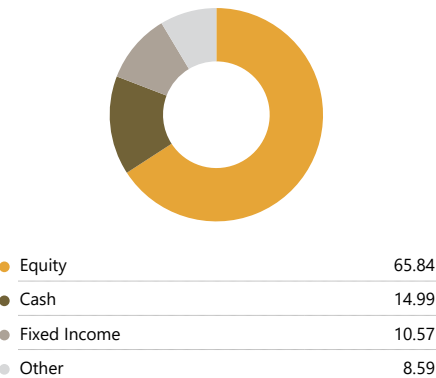
ANNUAL COMPOUND RETURNS

ASSET ALLOCATION (%)



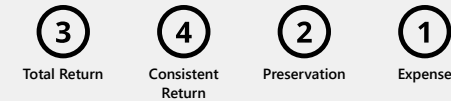

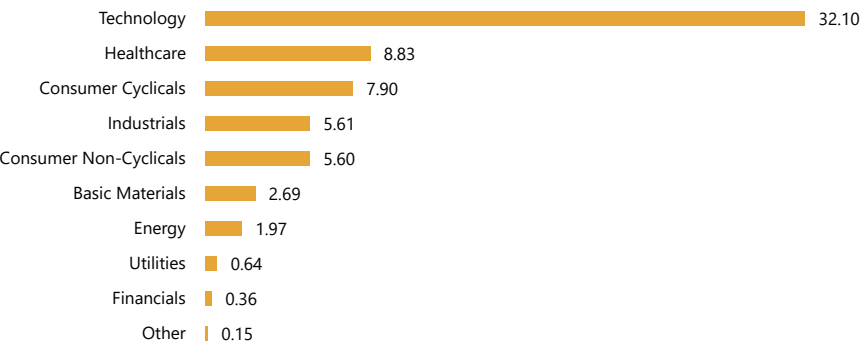

SECTOR BREAKDOWN (%)



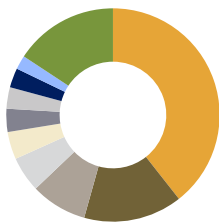

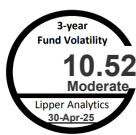
